Overview Unjust enrichment occurs when Party A confers a benefit upon Party B without Party A receiving the proper restitution required by law. This typically. Unjust enrichment means when a person unfairly gets a benefit by chance, mistake or another's misfortune for which the one enriched has not paid or worked and morally and ethically should not keep. A person who has been unjustly enriched at the expense of another must legally return the unfairly kept money or benefits. Legal definition of unjust enrichment: the retaining of a benefit (as money) conferred by another when principles of equity and justice call for restitution to the. In addition to claims in restitution for unjust enrichment or wrongful acts, the law provides remedies against parties who have assisted others in carrying out acts.

Although the unjust enrichment principle often operates positively, in the sense that the claimant must establish that the defendant has been unjustly enriched.

The Supreme Court in *Patel v Mirza* [] UKSC 42 has reviewed the doctrine of illegality and sought to clarify the extent to which it applies in civil proceedings. The legal definition of Unjust Enrichment is Benefiting from the action or property of another without legal justification.
